Residential Super Off-Peak Time-of-Use Electric Vehicle Frozen

AVAILABILITY

Available throughout the Company's entire electric service area where the facilities of the Company are of adequate capacity and are adjacent to the premises. As of September 1, 2023, this rate will not be available to new customers. Existing customers will have until March 1, 2024 to take service under one of the Company's other rate options. If an existing customer does not elect to take service under one of the Company's other rate options, the customer will be placed on the TRREST rate.

APPLICABILITY

To all single-phase or three-phase residential electric service (subject to availability at point of delivery) in individual private dwellings and individually metered apartments when all service is supplied at one point of delivery and energy is metered through one meter.

Separately metered buildings (such as garages and or wells) that are on the same lot as a residential area will be classified as non-residential and the appropriate general service rate will be applied.

Customers taking service under this rate plan must have a qualified highway approved Battery Electric Vehicle or Plug-in Hybrid Electric Vehicle as determined by the Company's sole discretion and appropriate home charging equipment.

Not applicable to resale, breakdown, temporary, standby, auxiliary service, or service to electrical equipment that causes excessive voltage fluctuations.

Customers may switch between applicable rate tariffs once in a rolling twelve month period.

Service under this rate will commence when the appropriate meter has been installed.

CHARACTER OF SERVICE

The service shall be single-phase or three-phase, 60 Hertz, and at one standard nominal voltage as mutually agreed and subject to availability at point of delivery.

A monthly bill at the following rate plus any adjustments incorporated herein.

The Power Supply Charge is the sum of the Base Power Supply Charge and the Purchased Power and Fuel Adjustment Clause (PPFAC), a per kWh adjustment in accordance with Rider-1-PPFAC. PPFAC reflects increases or decreases in the cost to the Company for energy either generated or purchased above or below the base cost per kWh sold.

TIME-OF-USE TIME PERIODS

The Summer On-Peak period is 3:00 p.m. to 7:00 p.m., Monday through Friday (excluding Memorial Day, Independence Day, and Labor Day).

The Winter On-Peak periods are 6:00 a.m. to 9:00 a.m. and 6:00 p.m. to 9:00 p.m., Monday through Friday (excluding Thanksgiving Day, Christmas Day, and New Year's Day).

The Super Off-Peak periods are 10:00 p.m. to 5:00 a.m. daily, Monday through Sunday.

All other hours are Off-Peak. If a holiday falls on Saturday, the preceding Friday is designated Off-Peak and Super Off-Peak; if a holiday falls on Sunday, the following Monday is designated Off-Peak and Super Off-Peak.

MONTHLY LIFELINE DISCOUNT

Current and new eligible customers may qualify for a monthly Lifeline discount on their electric bill. See TEP Rider R-21, Residential Lifeline Discount, for eligibility criteria and program details.

DIRECT ACCESS

A Customer's Direct Access bill will include all unbundled components except those services provided by a qualified third party. Those services may include Metering (Installation, Maintenance and/or Equipment), Meter Reading, Billing and Collection, Transmission and Generation. If any of these services are not available from a third party supplier and must be obtained from the Company, the rates for Unbundled Components set forth in this tariff will be applied to the customer's bill.

FOR DIRECT ACCESS: ARIZONA INDEPENDENT SCHEDULING ADMINISTRATOR (AZISA) CHARGE

A charge per kWh shall, subject to FERC authorization, be applied for costs associated with the implementation of the AZISA in Arizona.

ADDITIONAL NOTES

Additional charges may be directly assigned to a customer based on the type of facilities (e.g., metering) dedicated to the customer or pursuant to the customer's contract, if applicable. Additional or alternate Direct Access charges may be assessed pursuant to any Direct Access fee schedule authorized.
