



**Rider-21
Residential Lifeline Discount**

AVAILABILITY

Available throughout the Company’s entire electric service area to any residential Customer who meets the eligibility criteria below.

ELIGIBILITY

1. The TEP account must be in the Customer’s name applying for a Lifeline discount.
2. Applicant must be a TEP residential customer residing at the premise.
3. Applicant must have a combined household income at below 200% of the federal poverty level. See Income Guidelines Chart on TEP’s website at www.tep.com or contact a TEP customer care representative.

RATE FOR ELECTRIC SERVICE

Customers taking service on this rate rider must take electric service on one of the Company’s current residential rate plans. Rates for electric service shall be subject to the terms and charges contained in the Customer’s applicable residential rate plan except for the Lifeline discount specified below.

MONTHLY LIFELINE DISCOUNT

For current and new eligible Lifeline customers taking service hereunder, the monthly bill shall be in accordance with the Customer’s applicable residential rate plan except that a discount of \$20.00 per month shall be applied.

MONTHLY LIFELINE DISCOUNT - DISCONTINUED

New customers, including those who move, are no longer eligible for the discounts in the table below. For current Lifeline customers formerly taking service under one of the following discontinued Lifeline rates, the monthly bill shall be in accordance with the Customer’s applicable residential rate plan except the discount per month shall be applied as follows:

Discontinued Lifeline Rate	Discount
Residential Lifeline/Senior: TRRESLS, TRRESTLS, TRRSPLS, TRRSPTLS	\$31
Residential Lifeline Medical: TRRESLM	\$42
Residential Lifeline Medical: TRRESTLM, TRRESPLM	\$64
