Application Process

1. Provide the invoice or receipt from the HVAC contractor that includes which coil on HVAC system was cleaned, and refrigerant recharge.
2. Submit a complete application within 30 days of project completion.
3. Receive your incentive check within 6 to 8 weeks of final application approval.

Franklin Energy is a Tucson Electric Power authorized contractor responsible for implementing this program through December 31, 2025.

The Efficient Home Program (Program) is approved by the Arizona Corporation Commission and implemented by Tucson Electric Power (TEP). TEP in turn contracts with Franklin Energy to administer the Program. As stated in the above terms and conditions, an invoice or receipt (or copy) of work completed must be submitted to be eligible for rebates. If submitted document does not detail work performed, the contractor must provide his/her signature in the form above in order for applicant to be eligible for rebates. The Program is funded by TEP customers as a part of their utility rates. Program funds, including any funds utilized for rebates or incentives, will be allocated on a first-come, first-served basis until such funds are no longer available. This Program may be modified or terminated without prior notice. Tucson Electric Power offers residential customers rebates for coil cleans and refrigerant recharges on existing systems at a residential premise when using a licensed HVAC contractor.

Program Eligibility

To participate in the program, you must:

- Be a TEP residential customer.
- Work with an HVAC contractor to provide a coil clean or refrigerant recharge service.
- Use an HVAC contractor with a HVAC License in the state of Arizona.
- Include the invoice or receipt for the work completed.
- Agree to the terms and conditions of the application, including inspection of work.

How to Submit Your Application

Submit a completed rebate application form with the following:

1. Copy of the original invoice/receipt that includes description of what coil(s) were cleaned and/or refrigerant recharged.

TERMS AND CONDITIONS

1. To qualify for rebates, the customer must meet the following requirements:
 - Must be a TEP customer.
 - Must be a residential customer.
 - Must use a licensed HVAC contractor that is licensed to work in the state of Arizona.
 - Must fill out the application to be eligible for rebate.
 - Must include the invoice listing the work completed.
 - Must agree to the terms and conditions of the application including inspection of work.
2. The service must be purchased and installed by December 31, 2025.
3. Submit complete application within 30 days of project completion.
4. Receive your incentive check within 6 to 8 weeks of final application approval.
5. Rebates will be processed and paid on a first come, first served basis. Rebate will be processed in approximately 6 to 8 weeks. Terms and conditions are subject to change without notice.
6. Limit of one rebate application per calendar year for each service: Outdoor Coil Clean, Indoor Coil Clean, and/or Refrigerant Recharge.
