## 2025 Application Form

### Application Process

1. Within 30 days of project completion, submit your completed and signed application, along with the following required documents:
  - Copy of the original invoice/receipt that lists pre and post R-values.
  - Photo documentation of pre-existing R-value taken next to a ruler.
  - Photo documentation of post-installation R-value taken next to a ruler.

*Please note: If the rebate is transferred to the contractor, both the customer and contractor must sign application.*

2. Receive your incentive check within 6 to 8 weeks of Final Application approval.

**Tucson Electric Power offers residential customers up to \$1,000 for the purchase and installation of attic/roof insulation at a residential premise when using a licensed insulation contractor.**

### Program Eligibility

To participate in the program, you must:

- Be a TEP residential customer.
- Install insulation at a residential home.
- Use an insulation contractor with a Residential Contractor License in the state of Arizona.
- Install accepted insulation.
- Currently have less than an existing R-19.
- Install new insulation greater than or equal to a total of R-38.
- Include the invoice for the work completed.
- Agree to the terms and conditions of the application, including inspection of work.

### How to Submit Your Application

Submit a completed rebate application form with the following:

1. Copy of the original invoice/receipt that includes pre and post R-values listed.
2. Photo documentation of pre-existing R-value taken next to a ruler.
3. Photo documentation of post installation R-value taken next to a ruler.

If the rebate is transferred to the contractor, both the customer and contractor must sign application.

### TERMS AND CONDITIONS

- To qualify for rebates, the customer must meet the following requirements:
  - Must be a TEP customer.
  - Must be a residential customer.
  - Must use a licensed insulation contractor that is licensed to work in the state of Arizona.
  - Must fill out the application for rebate.
  - Must include the invoice for the work completed.
  - Must agree to the terms and conditions of the application including inspection of work.
- The qualified insulation must be purchased and installed by December 31, 2025.
- Contractor must submit a copy of the original invoice/receipt that includes pre and post R-values listed.
- Submit complete application within 30 days of project completion.
- Receive your incentive check within 6 to 8 weeks of Final Application approval.
- Flat-roofed homes: Insulation added to the roof deck will qualify for incentives when the attic space is converted into an unvented, conditioned space. Insulation in the existing attic must meet program requirements. If contractor converts existing attic space into an unvented, conditioned space, description of work must be stated on invoice.
- Rebates will be processed and paid on a first come, first served basis. Rebate will be processed in approximately 6 to 8 weeks. Terms and conditions are subject to change without notice.
